* In April 2007 the U.S. Supreme Court issued their Gonzales v. Carhart PBA opinion so PBA-specific fundraising efforts rapidly fell off. Therefore this report reflects only 25% of 2007 revenue.
 ** In 2008, Right to Life of Michigan, one of the groups that most misled their donors, not wanting to say goodbye to their 15-year cash cow, introduced yet another meaningless PBA bill, so all of their 2006 - 2007 dollars are included above.
 Note: The conclusion of this effort, that the PBA "ban" was a cash cow, was reached without having to research every RTL group in all 50 states. Additionally, candidates and their party organizations brought in many millions more from this fraudulent fundraiser. Even pro-abortion candidates like SD's Tom Daschle who received political cover by voting for the meaningless PBA ban.
